



## **Conditions of participation for the BISON Refer-a-Friend program for Germany, Austria and Switzerland**

By participating in this program, you agree to the following conditions of participation:

All users of BISON of EUWAX AG (BISON users) who, at the time of participation, are domiciled or permanently resident in Germany, Austria or Switzerland, have successfully completed the relevant registration process and are activated ("BISON users") may participate in the BISON Refer-a-Friend program. Subsequent registration and activation does not entitle the user to participate.

Employees of a company of Boerse Stuttgart Group are excluded from participation.

For the successful recommendation of a new customer, the BISON user will receive the bonus described in the promotion up to five times per calendar month.
